1. Welcome

Mrs. Gloria Nuñez (AHS), DELAC president, opened the meeting at 5:04pm with nine members present.

2. Approval of the agenda

3. Reading and approval of the minutes for February 16, 2023

Mrs. Maria Jimenez (EMHS) read the minutes. Mrs. Gloria Nuñez (AHS) suggested that it be added that the meeting was virtual, under welcome at number 1. Mrs. Ia Mejia (MVHS) corrected in the Spanish minutes that the word *segundo* is not correct, rather *segunda*, in numbers 2, 3, and 9. Motion: Mrs. Maria Jimenez (EMHS) made the first motion to approve the minutes.

Second: Mrs. Maria Lazcano (EMHS) seconded the motion.

Vote: <u>10</u> in favor, <u>0</u> against <u>0</u> abstentions (<u>10</u> members present)

4. <u>Review and comment on LCAP [I-EL 2.1(g)]</u>

Mrs. Edith Echeverria (AAFE) showed parents where on the district's website they can find the Local Control and Accountability Plan. Districts receive more funding depending on the percentage of students classified as English Learners, foster students, and low-income students; the percentage in our district is between 88% and 92%. Districts have to show how they use the extra money for those students. Mrs. Edith Echeverria (AAFE) showed a graph of the different funds that the district received last year. There are five goals in the plan that reflect eight priorities of the state, and in each goal, there are different actions. The goals that she briefly went over are: (1) the district will offer instruction to students by appropriately assigned, fully credentialed teachers in clean and well-maintained schools (2) the district will provide students with the skills and courses that will allow

them to graduate from high school college and career ready (3) the district will provide students with high-quality instruction that supports their academic achievement (4) the district will provide varied opportunities to support, promote and maintain a high level of parent and family engagement (5) the district will maintain safe learning environments that actively engage students and promote social and emotional health. At the next meeting there will be a summary of the five goals and actions, and a discussion of what can be done to achieve each goal.

5. Site ELAC Reports

Arroyo: The president, Mrs. Gloria Nuñez reported on behalf of Arroyo

• Information was given about the single plan for student achievement, and the three goals are (1) to increase reading proficiency and literacy, (2) to increase math achievement, and (3) to increase parent involvement. The percentage number of English learners was shown. A review of the graduation data was reviewed.

El Monte: Mrs. Maria Jimenez reported on behalf of El Monte

• They talked about the school plan for academic achievements and showed the graph of the results of the exams of the year 2022. Students who arrive at the age of 17 and do not reach their required credits, are given the option of taking after school classes in the adult school, or ending up as fifth-year students by taking summer classes. For newcomers and English learners, the credits required for graduation are 130 compared to the 220 required. Students may earn a state seal of bilingual literacy on their graduation certificate when they study another language other than English for three years or more and earn a GPA of 2.0 or higher.

Mountain View: Mrs. Mayra García reported on behalf of Mountain View

• Information regarding the A-G requirements were given. A graph of the number of English learners that graduated was shown and the number was low. Information regarding results of different exams was given. The state seal of bilingual literacy was also discussed.

Rosemead: Mrs. Carmen Perez reported on behalf of Rosemead

• Information regarding the percentage of students that graduate was given, along with the requirements for graduation.

La South El Monte: Mrs. Sandra Heredia reported on behalf of South El Monte

• The results of the CAASP exam taken after the pandemic were reviewed. Information was given regarding the strategies and support that students are given for English and mathematics to be able to raise their grades.
