1. Welcome

Mrs. Gloria Núñez (AHS), DELAC president, opened the meeting at 5:12pm with eight members present.

2. Approval of the agenda

Mrs. Gloria Núñez (AHS), asked the members to review the agenda. Motion: Mrs. María Jiménez (EMHS) made the first motion to approve the agenda. Second: Mrs. Sandra Heredia (SEMHS) seconded the motion. **Vote:** 8 in favor, 0 against 0 abstentions (8 members present)

3. Reading and approval of the minutes for November 17, 2022

Mrs. Gloria Núñez (AHS) asked the secretary, Mrs. María Jiménez (EMHS) to read the minutes. Mrs. María Jiménez (EMHS) corrected that the date of November under number 13 should be November 17.

Motion: Mrs. Ia Mejía (MVHS) made the first motion to approve the minutes. Second: Mrs. Mayra García (MVHS) seconded the motion. **Vote:**\_8\_ in favor, \_0\_ against, \_0\_ abstentions (\_8\_ members present)

4. <u>Review the Uniform Complaint Procedure (UCP) [II-UCP 02]</u>

Mrs. Linda Rosales (District) showed a copy of the form and informed that the district is primarily responsible for compliance with federal and state laws and regulations related to education programs and plans, and unlawful discrimination, harassment, intimidation, or bullying. Mrs. María Jiménez (EMHS) asked where one can get a copy. Mrs. Gloria Núñez (AHS) replied that at the schools. Mrs. Linda Rosales (District) mentioned that school principals have copies. Mrs. Edith Echeverria (AAFE) said the district also has copies. Mrs. Gloria Núñez (AHS) let it be known that this form is filled out as a last resort if there is no response. Mrs. Mayra García (MVHS) asked that if she understood correctly, one first goes with the teacher, then the principal and finally, if there is no

response, that is when one fills out the form. Mrs. Edith Echeverria (AAFE) said that after the principal one usually talks to the counselor and at the end, if necessary, fills out the form.

## 5. <u>Review and comment on the LEA's reclassification procedures [I-EL 2.19(e)]</u>

Mrs. Linda Rosales (District) reviewed the reclassification procedure. First, a competency assessment in English is done, and the student has to receive a result of level 4 in the ELPAC test. Second, is the performance of basic skills, and for this the student has to obtain a level of three or better in the English exam. Third, an evaluation of academic performance is carried out with the teacher. The student must have received a grade of "C" or better in English class for two consecutive semesters. And fourth, parents are consulted and informed of the support students have during the reclassification.

### 6. <u>Review and comment on the LEA's reclassification procedures [I-EL 2.1(f)]</u>

- a. Parent Notification of Reclassification Mrs. Linda Rosales (District) reported that parents are notified through a letter and a phone call. This letter informs parents of the reclassification criteria and requests a signature of consent to reclassify the student.
- b. Consent Form This form provides the student's evaluation and academic information demonstrating how the student met the criteria for reclassification. This form can be provided in person, by phone, or through a virtual meeting.
