Prequalification of Bidders

Bids will not be accepted if a Contractor has not been prequalified where prequalification is required. Prequalification documents are available from Quality Bidders via the El Monte Union High School District Website at https://www.emuhsd.org/Page/3891 (Or www.emuhsd.org; Departments; Purchasing; Prequalification; Click on the Quality Bidders link at the center of the page). Prequalification documents must be submitted no later than **Friday**, **January 6**, **2023**. Contractors will be notified by telephone, fax or by mail of their prequalification rating within a reasonable period of time after submission of their prequalification documents, but not less than five days prior to the bid opening date.

All General Contractors that hold an A or B license and all subcontractors that hold mechanical, electrical or plumbing license(s) ("MEP" contractors that hold C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43 or C-46 licenses), must be prequalified. It is the responsibility of the bidder to ensure that the bidder and all MEP subcontractors holding any of the licenses listed above, are properly prequalified before submitting a bid. This prequalification requirement applies even if the subcontractor will perform, or is designated to perform, work that does not require one of the licenses listed above, but the subcontractor holds one of the licenses listed above.

There will be a NON-MANDATORY Pre-Bid Conference at 10:30 A.M. on Wednesday, January 4, 2023 at South El Monte High School (meet at the flag pole) 1001 Durfee Ave., South El Monte, CA 91733.

Each bidder's bid must be accompanied by one of the following forms of bidder's security: (1) cash; (2) a cashier's check made payable to the District; (3) a certified check made payable to the District; or (4) a bidder's bond executed by a California admitted surety as defined in Code of Civil Procedure Section 995.120, made payable to the District in the form set forth in the Contract Documents. Such bidder's security must be in an amount not less than ten percent (10%) of the maximum amount of bid as a guarantee that the bidder will enter into the proposed Contract, if the same is awarded to such bidder, and

will provide the required Performance and Payment Bonds, insurance certificates and any other required documents. In the event of failure to enter into said Contract or provide the necessary documents, said security will be forfeited.
